Japan's powerful business lobby Keidanren, which has close ties with the trade and industry ministry as well as other government bodies, is dominated by energyintensive sectors that represent less than 10% of the economy, resulting in national policies that favour coal and hindering attempts to combat climate change, a new study said.

# Virginia finalizes ETS regulations and officially joins RGGI

On 8 July 2020, the Regional Greenhouse Gas Initiative (RGGI) formally welcomed Virginia as the newest participating state in the mandatory cap-and-trade program covering the power sector starting 2021. Virginia's inclusion in the group of linked ETSs increases the regional emissions cap coverage by almost 30%. Virginia has worked closely alongside other RGGI states since 2017.

# U.S. Senate Democrats unveil \$40bn-a-year plan to tackle climate change

Senate Democrats on Tuesday unveiled a plan to tackle climate change that calls for the U.S. government to spend more than \$400 billion a year to eliminate greenhouse gas emissions by 2050. None are likely to proceed in the current Republican-controlled Senate but could get traction if the chamber flips to Democratic control after November's election.

## China's new coal projects account 90% of global total in first-half of 2020 - study

China built more than half of the world's new coal-fired power plants this year and accounted for 90% of new planned capacity, a study showed on August 3, with Beijing still commissioning new projects even as capacity worldwide declines. Global coal-fired generation capacity saw a net decline of 2.9 gigawatts (GW) from January to June, the first drop on record for a six-month period, but China added 53.2 GW of capacity to its project

## Extended ETS outperforms carbon border adjustment in the power sector

Creating a carbon border adjustment mechanism would not work as well as extending the EU Emissions Trading Scheme to reduce global emissions and further integrate energy exporting countries into the European power market, argue András Mezősi, Zsuzsanna Pató and László Szabó. Carbon leakage occurs in any carbon pricing regime that is not global, which means all of them so far. That is inherently unfair to


pipeline in the first half of this year - 90% of the global total.



How To Retire Early: Making Accelerated Coal Phaseout Feasible and Just, Rocky Mountain Institute, Carbon Tracker Initiative, the Sierra Club

This report presents an analysis of nearly 2,500 coal plants around the world and shows that the cost of clean energy has fallen so far that new renewables outcompete new coal virtually everywhere. In addition, it is cheaper today to build new renewable energy capacity than to continue operating 39 percent of the world's existing coal capacity.
